Rector's Note

When the Normans conquered England in 1066 they brought with them a system of homage and fealty in which land and power, which meant the same thing in the middle ages, were held upon certain conditions known later as the feudal system. Those conditions were set by the top people, the king, the great nobles, the lesser nobles, the squires and so on. This "feudal system" spread to Scotland during the following century. What it meant was that for centuries our countries were controlled by rules made by a tiny elite of powerful men. As both England and Scotland became constitutional monarchies during the latter years of the 17th century, fusing into one state in 1707, the ancient way in which power was exercised was gradually replaced by a more and more democratic system. Today if we give homage and fealty it is because we choose to do so, not because we have an obligation. This seems a proper moment to make that choice.

Homage is defined as formal public acknowledgement of allegiance, acknowledgement of superiority or dutiful reverence. Fealty is the acknowledgement of the obligation to be faithful. These ancient words seem to have particular relevance to Madras College this session, for it is a year when several of our finest staff are about to depart, having given splendid service to the school for many years. We may not go so far as to speak of reverence or superiority - a college is by definition a body of colleagues with common functions and privileges - but we most certainly can admire the constancy, faithfulness and allegiance shown to the school by those about to leave us. Some brief details about departing colleagues are included in the "Staff Notes" section. Shall we see their likes again?

Those of us remaining will of course remember that people who make fine contributions are best celebrated by the results of their good works - good policies and procedures, good systems, good departments, good relationships, and good repute. We then have the obligation to be faithful, to carry on the good work in deed and in spirit, keeping a balance between continuity and change, being prepared to stand up and be counted if the latest "fad from afar" seems as relevant or useful as a horse to a Venetian.

In other ways it has been an important year for the school. We have at last managed to achieve some combined focus by councillors, officials and school

representative groups on the long-term future for the fabric - the buildings - of Madras College. A response by the Council is eagerly awaited so that plans may be put in motion for improvements, short and long term, to the learning and teaching facilities of the school.

The promised consultation about school dress produced interesting results, most pupils backing the status quo with only minor amendments, but clear that we should apply our dress code in a consistent way. Parental views and support have been sought, and will be further canvassed in the new session.

Another area in which consistency of standards will be vital is the new statement of "Ground Rules" covering common expectations about the way we should work, study, coexist and cooperate in this large school. This simple text was achieved after exhaustive consultation by staff and pupil groups. A statement of the agreed wording of our Ground Rules is printed on page 7 for the information of parents.

The life and work of Madras College power on. We are becoming better at coping with the constant change expected of us and are moving closer to having a culture of change in the institution. The concept of "the learning school" in which we do not resist change so much as evaluate its potential benefits may not be so far away. This cool appraisal of the merits or otherwise of change may also help us to manage some of the strains and stresses of modern

education. Echoes of this are also appearing in the school agreements all teaching staff are negotiating within "McCrone", our national scheme for the profession for the 21st century. There is, however, a long way to go, much to be done. As things are at present teachers work well beyond the target of 35 hours per week (a recent survey suggested that about 44 hours was average), and it is difficult to imagine when this figure will be achieved given the current workload and expectations. The Council's plans under the McCrone scheme to increase time for teaching by reducing administrative burdens are awaited with interest.

Lastly, all of the above makes no sense unless we put the pupil, and cooperation between parents and staff at the centre of our thinking. It is therefore most heartening to have had so many examples this session of productive dialogue and activity between pupils, parents and staff. I wish to thank most deeply all those who have assisted in joint enterprises this session. How interesting that "enterprise" is to be the next buzzword in Scottish education. We've been at it for years!

On behalf of all staff I wish all parents and pupils a well-deserved, sunlit, invigorating and even perhaps enterprising holiday.

STAFF RETIRING

This session will for years be remembered as the one at the end of which three long-established promoted staff retired - Mr Halliday, Mrs Fraser and Mr Lindsay, and three other members of staff retired - Mr Linton, Dr Malcolm and Mrs Tait.

Mr Halliday came to Madras as Assistant Rector in 1984. He supervised and coordinated the development of Standard Grade and Scotvec courses across the school to implement the new principle of "certification for all". He showed a rare grasp of content and structure of the curriculum while in charge of this process and also in his creation of course choice options and SCE (later SQA) examination arrangements. Soon he was to be put in charge of the timetable, an immense and complex operation in Madras. While Mr Halliday carried out such tasks with speed, skill and efficiency, he was also an important member of the senior management team, as year head, as faculty link for technological subjects, but most of all as a quiet and persuasive teacher and colleague who always strove to achieve positive outcomes from difficult situations. Generations of Madras pupils will remember Mr Halliday most of all, however, for his famous assembly stories - the 17 camels, etc. He has done much in recent years to reorganise the school day, change the S3/4 curriculum to offer eight courses to most pupils, but most of all to timetable the Higher Still programme in the senior school. During the last 10 years he has also served on several national committees for the Scottish Secondary Teachers' Association. He served the School Board with distinction for many years as teacher member.

Mrs Fraser came to Madras in 1980 as Chemistry Teacher, became Senior Teacher in 1989 and was appointed as Principal Teacher of Chemistry in 1993. During her time in Madras she contributed to many significant changes to the curriculum which were taking place - her Principal Teacher in her early years, Mr Christie, noting how well she had assisted with Standard Grade, Scotvec Modules and Revised Higher. She had also been in charge of the re-writing of the S1/2 Science course between 1988 and 1993, a major exercise involving all Science colleagues. Once appointed as PT in 1993 Mrs Fraser used her talent for organisation and leadership to the full, showing the necessary determination, diplomacy and wider understanding of

school or pupil needs that mark out the skilled head of department. She thus leaves a strong and successful department with an impressive esprit de corps and desire to continue to do great things in the future. During her 22 years Mrs Fraser has also taken part in a wide range of activities, has given outstanding service to school debating and public speaking, and has represented colleagues in both Parent-Teacher Association and School Board.

Mr Lindsay came to Madras in 1969 as teacher of English, his first post. His career has therefore spanned the introduction of the comprehensive system, the raising of the leaving age to 16, Munn and Dunning discussions leading to Standard Grade, TVEI, Alternative Higher, Revised Higher, Modules, 10-14, 5-14, and now Higher Still. In 1972 Mr Lindsay became Depute Principal Teacher of English to Mr Edgar, then in 1985 Principal Teacher. His early work in liaison with primary schools gave a solid foundation to the 5-14 programme while his regional work in Standard Grade helped the department to get to grips with the new challenge. Thus it has been in more recent years with the various initiatives being faced and implemented. A manager of a very large department Mr Lindsay has also made contributions to the wider life of the school. Most noteworthy have been his early work in using information technology to assist the school's presentation of official publications and his regular use of his rare literary talent, particularly in verse. The school Burns Suppers were for over a generation a forum for engaging flights of poetic fancy. All have suffered or celebrated his acerbic wit! Other school events have benefited from Mr Lindsay's famous skill, such as at the S6 Ball of 2001 when, as requested, he mentioned all 200 or so members of the year. Of the many characterful teachers Madras has produced Mr Lindsay must surely have a special place.

Dr Malcolm, Biology Department, came to Madras in 1980. Despite his background of high academic qualifications and university teaching he

rapidly became established as an enthusiastic and stimulating teacher whose individual and informal style was appreciated by pupils of all stages and abilities. Dr Malcolm, able to communicate his personal interest in Biology, brought a breadth of knowledge and a joy in learning for its own sake that rubbed off on pupils in his classes. His connections in the golf world and his great interest in the history of the game were used to very good effect during his teaching career, in local competitions, in coaching of teams of girls and boys, in writing of annual golf reports and in his influence in establishing golfing exchanges. In the Ohtawara Exchange he has also contributed annually to the hosting of Japanese visitors by leading a group visit to the Highlands. Dr Malcolm has donated many family artefacts to the school archive ensuring that generations of pupils and staff derive benefit from these original sources of school history.

Mr Linton, Design and Technology Department, came to Madras in 1981. His interest in both the traditional and modern sides of the subject was clear from the outset. For a time, indeed, he worked in the Computing Department having taken extra training courses in microprocessors and interfacing. Overall, however, his main interest was in the craft side of the subject, in which he was able to bring the best out of many pupils. This was also true of his interest in pupils with special educational needs. Mr Linton gave active support to his teacher association and contributed particularly in matters of safety policy and practice.

Mrs Tait, Modern Languages Department, joined the staff at Madras in 1990. Able to teach both French and German she brought a clear and orderly classroom style from which pupils benefited. This clarity and sense of purpose ensured that all of Mrs Tait's pupils knew what was expected of them and most responded accordingly. As a result the SCE (later SQA) performance of her classes was never in doubt. Mrs Tait also assisted colleagues in many curricular developments in both her languages.

Other Staff News

In May Miss Ashley joined the Modern Studies Department and Ms Shields was appointed as Assistant Principal Teacher of Guidance. At the end of the session Mrs Gourley demits her acting duties as Principal Teacher of Learning Support as does Miss Hutchison as Principal Teacher of Guidance, Mrs Nicol and Mrs Welsh, respectively, resuming their duties. Dr Tomb, Principal Teacher of Chemistry and Mr Darge, Principal Teacher of English, take up their posts in the new session. Also joining us in Maths is Mrs Burrows. Lastly we would like to thank Fraulein Irnstorfer and Mademoiselle Mortolini for their excellent work as “assistantes” in Modern Languages this session.

Rock Band News

Blair Rennie and his big brother Michael took these honours. School Dress Code

All parents have recently been sent a copy of the amended dress code shown below. Many thanks to all who assisted in this exercise. Our expectation is that all pupils will keep to the code thus indicating their commitment to school. As always parental support is vital and it is hoped that items purchased in preparation for next session will reflect the agreed code. Sales of fleeces and hoodies are going particularly well. Orders may be placed at any time via the school offices.

- Plain navy or black v-necked jersey or sweatshirt
- Formal black or navy blue trousers or skirt
- Plain white or light blue shirt or polo shirt
- School tie
- Dark footwear
- Labelled fashion or cult items are not acceptable school wear
- Safety and Security: Pupils’ clothing must not place them at risk of accident. The length and width of trousers and the height of heels on shoes are two aspects of dress that may cause injury. Pupils are therefore expected to wear clothing that does not add to personal risk.
- For school events a high standard of appearance is expected. Staff will make expectations clear to pupils for particular events.
- Additional items of school wear may be made available for pupils to purchase. These are, at present, the school fleeces, hoodies and scarf.

Duke of Edinburgh’s Award

On Wednesday 19th June, the school held a presentation of certificates and badges for the Duke of Edinburgh’s Award Scheme. Mr J Macgregor, Senior Manager (Education) issued the 7 Silver and 15 Bronze certificates.

In all these exchanges, it was clearly apparent that Madras College is held in exceedingly high esteem. The Band, as ambassador, is proud to be a part of this and to further enhance the reputation of the school whenever possible. Other events this term include an appearance for the Quad Fund on home turf, the usual Summer Concert, Retreat at the University of St Andrews Graduation Ball, Bow Butts Bandstand (3 pm on Sunday June 30th, if you are passing) and Anstruther Lifeboat Gala on August 10th. Sculpture in the Quad

The Maths Challenge Contest 2002

In this year's event Madras College achieved an excellent total of 19 Gold and Silver awards. This is the best result for the school since 1998.

The Prizewinners were entertained in the morning by Mr Bill Richardson, Chairman of the Nation Committee responsible for the Mathematical Challenge Competition, who led the assembled 140 budding young mathematicians through a series of stimulating problem solving exercises. Audience participation was the order of the day and the Maths Challengers rose to the occasion with a dazzling display of their problem solving skills.

There was general agreement that the day had been a great success. Thanks must go to the staff of the Mathematics Department at St Andrews University for hosting the event and for making the day such a memorable one.

'The Three Sisters' by Anton Chekhov, performed by Madras College Quad Theatre Company

Chekhov's longest play, 'The Three Sisters' is not an obvious choice for a school production, but under the inspired direction of Mrs Esler, this one was a resounding success. The direction of a cast of eighteen on a tiny stage was masterful. The simplicity of the set and the smallness of the quad Theatre all helped to enhance the feelings of intimacy, even claustrophobia, which the play evokes.

All three of the sisters were very well cast. Sophie Palmer's quietly controlled performance captured the weariness, but rock solid dependability of Olga. Irina, played by Eleanor Scott, was just right. Her wistfulness for the past was very clear, as was her longing for happiness; all of which made her pain at the end very real.

From her first appearance, pacing relentlessly up and down, with a ramrod stiff back, Angela Orr as Masha dominated the scene. Her broodiness and frustration with her life and her ineffectual husband, played brilliantly by Ben Anderson, were very evident, as was her growing passion for Lieutenant Colonel Vashinin, played with verve and panache by Mr Latona.

Jenny Swingler as the appallingly selfish and flirtatious Natasha was a welcome relief from the intensity of the three sisters, and her husband, Andrie, played convincingly by Struan Paterson, was very much putty in her hands.

Mr Dewar as Dr Chebutykin was full of embittered wisdom and was frighteningly

convincing as an old person, as was Julia Higgins as Anfisa, the loyal servant. Jamie Watson and Fingal McKiernan gave effective performances as Captain Solyoni and Baron Tuzenbach respectively, backed up admirably by the rest of the cast: Mark Burns as Fedotik, Jo Edwards-Fox as Rode, Mr Lyden as Ferapont, Lesley Aitken, Christina Ciftci, and Meredith Palmer as maids.

The violin music expertly played by Dominic Esler, helped to set the mood, as the tension was slowly but inexorably built up. The final moments of the play, with the three sisters clutching at, yet supporting, one another, was very moving.

A review in the Sunday Herald of another Chekhov play began by saying that Chekhov was enjoying an 'annus mirabilis' in Scotland at the moment. Anyone who saw the Madras College Quad Theatre Company's performance of 'The Three Sisters' would agree.

Great Valley High- Madras Exchange

The UK Schools Junior Maths Challenge Contest 2002

A remarkable 51 awards were gained by Madras College contestants this year. There were 12 Gold awards, 17 Silver and 22 Bronze. Special congratulations go to Sheila Norrie in S3 for achieving the top score out of all our contestants. In addition to her Gold award Sheila will receive a special 'Best in School' award. She has also been invited to sit the prestigious UK Junior Maths Olympiad. This 2 hour paper consisting of 16 questions should stretch her problem solving skills to the limit!

PERFORMANCES

Madras College annually presents four major concerts showing the work of the Music Department. The Summer Concert saw the culmination of the Traditional Music Residency in the form of two items within a programme also featuring Pipe Band, Wind Band, Madras College Singers and soloists. Rob MacKillop, Musician in Residence conducted an item for orchestra and Morag Ann Elder, also brought in as part of the residency, directed the Fiddle Group in their contribution. Rounding off the year, Fiddle Group and Orchestra will play to the last at the closing assemblies, concluding the official business of the school year.

Wind Band

Under the watchful eye and energetic directorship of Mrs R Craib, Instructor for Woodwind, the Wind Band again prepares to squeeze into the Bandstand to delight their following. These concerts frequently attract a crowd of about 200 townsfolk and visitors and it would be a pity if the efforts of staff and players alike – preparing an hour's worth of repertoire with no repeats is a staggering feat for a school band – were not to have such a hearing in their home town. However, it is hoped that the Community Council which promotes the series of Bandstand concerts will be able to find volunteers willing to run the events in years to come following the 'retirement' of Archie Strachan from this activity after many years of dedicated involvement.

Hadrian's Wall Excursion



Fifty pupils and staff visited Hadrian's Wall this term in a joint Classics and History venture. Due to foot and mouth restrictions being lifted, the group were able to walk on the Wall from Steel Rigg to Homesteads and at Walltown Crags.

LITTER LIFTING

REWARDING EXPERIENCE

As part of the School Development Plan this session, a target area has been 'Rewarding Positive Behaviour - Department Strategy'. What follows are two accounts that reflect general departmental success in the exercise.

• Social Subjects Positive Behaviour Programme

This year, the Social Subjects Faculty ran its own Positive Behaviour Programme.

Within Geography, History and Modern Studies individual S2 pupils were awarded points for being organised for class, by bringing their Planner, and for behaving in a positive way by avoiding punishment exercises and detentions. These individual points were then aggregated to produce a class total and at the end of the year the class with the most points became the S2 Class of the Year.

Congratulations to 2B therefore for achieving a very high level of organisation and behaviour and in doing so becoming the S2 Social Subjects Class of the Year. We hope you enjoyed the celebration party!

Congratulations also to the rest of S2. The teachers within the Faculty were most impressed with the levels of effort

and application from all class groups. Well done!

• English 'Success Certificates' to extend to S2

At the start of the session, the English Department introduced a new system of Certificates, designed to reward good effort and positive attitude. This has proved to be extremely popular with pupils, and staff have found it very useful in motivating classes.

All teachers in the department have a rubber stamp, which is used to record a 'success' in the pupil's planner. The definition of 'success' is wider than simply a high score in a test. It could reward the conscientious use of the reading log, for instance, or a piece of work that a pupil has produced on his/her own initiative. The teacher makes a note in the planner every time a stamp is used, and this is a good way of letting parents know about the pupil's achievement.

Any pupil accumulating five such stamps is awarded with a Bronze Certificate. Ten leads to Silver, and fifteen to Gold. The certificates, signed by the class teacher, are also signed by Mr Mackay, the Assistant Rector with responsibility for the year group. He has

made a point of coming to classes and handing over the certificates in person, which has not only raised the profile of the exercise, but has also given him an opportunity to give words of encouragement to those who only have a stamp or two to go!

The experiment has been so successful that the department has decided to extend it into S2. The statistics for this session are interesting. There were 324 pupils in S1. Of these, no less than 161 gained Bronze Certificates – almost half the year group. A Silver Award was awarded to a further 57. There were 15 awards of Gold Certificates. This is quite an achievement for the pupils concerned.

Classical Success

There was another Lizzie Lawrenson (S5) Classics success, this time nationally in the Gilbert Murray essay competition.

The second year team won the Junior Latin Speaking Cup again. The school has now won it nine times since Mr Cleland introduced the event in 1974, more than any other school. There were places and finalists in all sections including Greek.

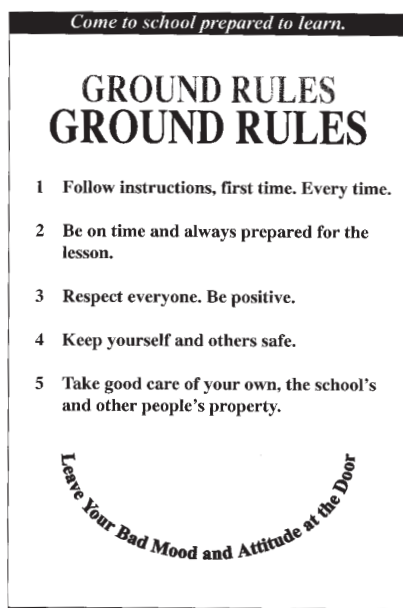
GROUND RULES

This session, a major initiative for both staff and pupils has been the creation of Ground Rules for School.

In November, Dr Geoff Moss, a Behaviour Management Specialist, involved teaching staff in a day of activities focussing on positive classroom management. From that, came a revision of the existing code of behaviour.

While, in many schools this is now a thing of the past – for lack of time or interest, who knows – the size of the entry (some 30 candidates this time) indicates our strength in this area and declares a continuing dedication to high standards. Instrumental Staff presenting the candidates – all of whom passed comfortably – are to be congratulated once again for their high quality work and ability to add value to their core work.

Burns Competitions

After their success in the school Burns Singing Competition, our team of three almost swept the board at the Fife Burns Competition. With Mr R Bell, Assistant Principal Teacher of Music at the helm, they cruised to victory with Alastair Downes taking second in the S1/2 class and Sonia Stevenson and Rowan MacKinnon-Pryde crossing the line first in their (S3/4 and S5/6) classes respectively. In the National competition, all three performed impressively against stiff opposition and Rowan took first prize in her class. Madras College has now won this class in the National three times in recent years. The points system used in this competition meant that the efforts of all three contributed to the awarding of Fife Region as the overall winner for this year.
